#### ORDER:

- The "Andhra Engineering College (formerly Atmakur Engineering College), Nellorepalem(V), Atmakur(M), Nellore Dist" was given Temporary affiliation for running Degree courses during the academic year 2015-16 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2016-17 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2016-17 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2016-17. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2016-17 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 28-11-2016.

- 1. The College should apply for NBA& NAAC accreditation
- 2. Principal appointment should be ratified by the University
- 3. Internet speed of 64 MBPS should be available as per norms
- 4. Library automation software to be procured
- 5. At least 3 legal system softwares and 20 legal application softwares to be procured
- 6. Subscription to e-journals should be as per AICTE norms
- Biometric system of attendance is to be adopted for all UG&PG students and staff (teaching & non-teaching)
- CC cameras are to be installed in allthe class rooms, Exam halls, corridors, vantage points, library & canteen

- 9. Faculty student ratio has to be maintained as per AICTE norms for UG courses
- 10. Faculty cadre ratio is to be maintained as per norms
- 11. Atleast 50% of faculty appointments haveto be ratified by the University.
- 12. 7/8 faculty in CE, 1/8 in EEE, 3/8 in ME, 6/15 in ECE and 1/13 in CSE are B.Tech. qualified
- 13. Internal marks are being given liberally.
- 14. Academic performance needs to be improved in UG programs
- 15. Enterpreneur Development Cell has to be established
- 16. NSS Unit has to be established
- 17. Journals for PG courses are to be procured
- 18. Aadhaar and PAN number has to obtained by all the teaching staff
- 3.
